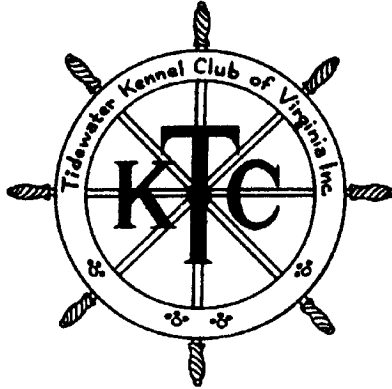
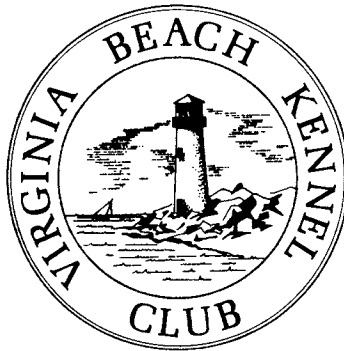

# **RESTRICTED OVERNIGHT PARKING MOTOR HOME/TRAILER PARKING NOTICE**

**PARKING SPACES WILL BE AVAILABLE FROM NOON WEDNESDAY, NOVEMBER 3, 2010**

Overnight reservations will be available at a fee of **\$80.00 per space** for the four-day weekend. RVs for less than Four Days will be **\$25.00/day**. Only RVs and Trailers will be permitted in the reserved area. **ANYONE ARRIVING WITHOUT THEIR RV OR TRAILER WILL FORFEIT THEIR PARKING SPACE.** A typical space is 40' x 18'. All units must be self-contained. No hookups will be available. No waste or gray water is to be discharged onto the ground. **NO CONES OR SIMILAR MEANS ALLOWED TO RESERVE SPACES.**

Exhibitors will be responsible for maintaining the cleanliness of their space. Anyone who does not leave the space in the same condition as when they arrived will be subject to forfeiture of future parking spaces.

Parking applications will be acknowledged upon receipt of the Fee and Application. Confirmation will be sent for each application. This confirmation is your admission ticket to the RV/Trailer parking area and must be presented upon arrival at the show grounds. **PARKING SPACE IS LIMITED. IF AN APPLICATION HAS NOT BEEN SUBMITTED PARKING MAY NOT BE AVAILABLE. IF SPACE IS AVAILABLE THE PARKING FEE IS \$100.00.**

Overnight reservations are a privilege extended by the City of Virginia Beach. Any arguing, abusive language or failure to follow the rules or the directions of officials on duty will cause **PERMANENT** forfeiture of all parking privileges without refund of fees paid and the possibility of discipline by the Event Committee. Parking is strictly at the exhibitors risk. The clubs are by virtue of the submittal of the reservation application indemnified by the application for responsibility for loss by fire, theft, or damage or loss of personal property, or the loss or injury to the animal exhibits in their charge while on the show grounds.

**Ramps at the sole discretion of the judge**, approved breeds may be judged on the ground or on a ramp: Boykin Spaniels, Clumber Spaniels, Sussex Spaniels, Welsh Springer Spaniels, Whippets, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden & Polish Lowland Sheepdogs. (Boykin Spaniels & Whippets may be judged on the table, ramp or on the ground.)

**Basset Hounds** are expected to be judged on the ramp during breed judging.

**This list may be revised** from time to time, and the current list can be found on the AKC website in Judging Operations.

**A judge requesting** the use of a ramp must give reasonable notice to the Show Superintendent/Show Secretary prior to the day of the show. AKC approval is not required.

**Ramps may be used** in emergency situations to judge any breed. (In all but emergency situations, the exhibitor has no recourse. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.)

**Exercise equipment** furnished by MB-F, Inc. Additional public exercise equipment will be provided by MB-F, Inc. No private exercise equipment will be permitted indoors at anytime. This includes no exercise pens as crating.

**No crates allowed in aisles at any time.**

**Grooming & crating** in designated areas only. **Stacking** will be enforced. **No mats or rugs on the floor. No soft mesh crates** will be allowed. Crate Tags are encouraged.

**All crates** must be stacked, violators will be subject to Event Committee Hearing.

**An area for Day Grooming** will be provided. It **MUST** be cleared **EACH DAY** 1 hour after Best in Show. Any equipment left in this area will be removed.

### Amateur-Owner-Handler Class (effective as of 1/1/2009)

Chapter 3, Section 7 - The Amateur-Owner-Handler Class shall be for dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog. This class is restricted to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler. Additionally, members of the immediate family or household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13).

### 00900. Best of Breed (01000. Variety) Competition

***NR2.24400.* Parade of Titleholders (DOBERMAN PINSCHERS SATURDAY ONLY)** - There will be a non-competitive Parade of Titleholders who are AKC Champions, Grand Champions or who have another AKC title (Obedience, Rally, Agility, etc.). **Entry fee is \$15.00.** Each entrant will receive a personalized Rosette listing the full name of the dog with titles. The entry blank must indicate "Parade of Titleholders".

A brief description of the dog will be read while the dog is presented. Exhibitors will be responsible for obtaining the form and giving it to the ring steward before lunch. Entrants in the Parade of Titleholders need not be entered in a regular class. Neutered dogs and spayed bitches may be entered in the Parade of Titleholders.

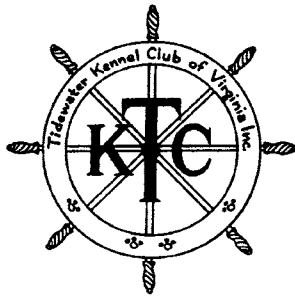

With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.*

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

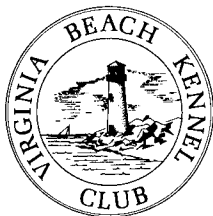
